Storage conditions:

Store in a dry place not above 22 °C.

Health hazards:

The products may cause an allergic reaction. We recommend an allergy test (Patch test) before the first application.

The products are not inflammable.

Recommended precautions for handling:

Wear protective gloves and avoid contact with eyes and skin.

First aid measures:

- <u>Ingestion</u>: Drink plenty of water and seek medical aid.
- Skin contact: Rinse with water; in case of an allergic reaction seek medical aid.
- Eye contact: If the product has come into the eye, rinse immediately with plenty of water, then seek medical aid.

CAUTION:

This product contains ingredients that may cause skin irritation on certain individuals and a preliminary test according to accompanying directions should first be made. This product must not be used for dyeing the eyelashes and eyebrows; to do so may cause blindness.

- i. the preparation may cause serious inflammation of the skin in some persons and a preliminary test should always be carried out to determine whether or not special sensitivity exists.
- ii. to make the test, a small area of skin behind the ear or on the inner surface of the forearm should be cleansed, using either soap and water or alcohol, and a small quantity of the hair dye as prepared for use should be applied to the area and allowed to dry. After twentyfour hours, the area should be washed gently with soap and water. If no irritation or inflammation is apparent, it is usually assumed that no hypersensitivity to the dye exists. The test should, however, be carried out before each application. On no account should the hair dye be used for dyeing eyebrows or eyelashes as severe inflammation or even blindness may result.
